



RSC Endorsement—Set in Stone: The Trump Legacy Laws

Bills that Codify Trump Executive Orders

March 11, 2025

From Day One, President Trump has delivered immediate wins for the American people. Now, our Republican-controlled Congress must reinforce his mission to eliminate government waste, secure our borders, and counter radical gender and DEI policies. While Republicans should continue pressing forward on reconciliation and the appropriations process, we must also seize this moment to advance President Trump's vision through decisive stand-alone bills.

Today, the Republican Study Committee proudly announces our new initiative: **Set in Stone—The Trump Legacy Laws**. This endorsement campaign champions key bills that will codify President Trump's agenda into permanent law. We call for swift floor votes in both the House and Senate on these critical pieces of legislation.

RSC-Endorsed Bills

House

Rep. Ogles (R-TN)—[End the Deep State Act](#)

- This bill would establish a new employment category for federal employees (“Schedule F”, now dubbed “Schedule Policy/Career”). This new category applied to career bureaucrats who served in positions of a “**confidential, policy-determining, policy-making, or policy-advocating character.**” Employees in Schedule F (now Schedule Policy/Career) jobs could be moved out of those roles and replaced with other career employees more able or willing to faithfully implement government policy.

Rep. Cloud (R-TX)—[Dismantle DEI Act](#)

- This bill would repeal the statutory authorizations for every DEI program and office, define and prohibit DEI practices and programs (e.g., trainings and pledges), and extends these prohibitions to federal contracts, accreditations, and regulations.

Rep. Roy (R-TX)—[No Taxpayer Funding for the World Health Organization Act](#)

- This bill would prohibit funds from going to the World Health Organization.

Rep. Smith (R-NJ)—[No Taxpayer Funding for Abortion and Abortion Insurance Full Disclosure Act of 2025](#)

- This bill would prohibit federal funds from going to abortion services, federal funds from going to any health plan that covers abortion, and federal tax credits and subsidies for health plans that cover abortions. The bill also requires health plans to disclose whether they cover abortion.

Rep. Emmer (R-MN)—[CBDC Anti-Surveillance State Act](#)

- This bill would prohibit the Federal Reserve from issuing a CBDC without Congressional authorization. The House passed this bill by a [216–192 vote](#) on May 23, 2024. The RSC Legislative Bulletin can be found [HERE](#).

Rep. Harrigan (R-NC)—[AMERICANS Act](#)

- This bill would reinstate over 8,400 service members who were wrongfully discharged, clear their records, restore their benefits, and ensure no future administration can weaponize mandates against our armed forces.

Rep. Babin (R-TX)—[Birthright Citizenship Act](#)

- This bill would modify birthright citizenship to ensure that it only applies to children born in the U.S. that have at least one parent that is a citizen or lawful permanent resident.

Rep. Gill (R-TX)—[REMAIN in Mexico Act of 2025](#)

- This bill would codify President Trump’s policy requiring asylum seekers to wait in Mexico.
